



## Double Play Wednesdays

### Official Rules

**Promotional Dates:** October 2, 9, 16, 23 and 30, 2024

**Promotional Times:** Every Wednesday from 8AM - 10PM

**Prize Maximum:** \$50 Free Play

1. To be eligible for this promotion, player (hereafter "player" or "players") must be a current ONE club member in good standing.
2. New members are qualified for this promotion upon valid enrollment.
3. This promotion is available at Quil Ceda Creek Casino.
4. This promotion will occur on Wednesdays; October 2, 9, 16, 23 and 30, 2024.
5. To qualify, guests must earn a minimum of two-hundred (200) promo slot points on their ONE club card to redeem their bonus Free Play.
6. When eligible guests swipe their ONE club card at a promotional kiosk, they will be prompted to view their current earned Free Play status in the "Double Play Wednesdays" promotion; upon viewing, they will be able to choose between a "Redeem" or "Keep Playing" button.
7. If the guest selects the "Redeem" button, the guest will be awarded the Free Play amount indicated on the screen; this will complete their redemption for that day.
8. If the guest selects the "Keep Playing" button, the guest will continue playing and must return to any QCC promotional kiosk before 10PM and select "Redeem" to receive their Free Play bonus.
9. Guests are limited to one (1) redemption each Wednesday.
10. Guests can earn a maximum of \$50 in Free Play each redemption period. One (1) Free Play bonus will be issued at the time of redemption.
11. Only base promo slot points are eligible for this promotion. Base promo does not award points for any slot play attained by Free Play or point cash-out.
12. Promo Free Play credits will expire twenty-four (24) hours from activation.
13. Guests must use promo free play credits at a slot machine; a cash-out option is not available for this promotion.
14. Any Free Play that is not activated within the allotted activation period, or expired, will not be reissued.
15. All prizes will be void in the event of a printing or screen error and regulatory approval will determine final award. All rulings made by management are final.

16. All prizes are nontransferable, and only redeemable by the player awarded.
