



\$250,000 All Wrapped Up

Official Rules

Promotional Period: November 25, at 6AM – December 29, 2024, at 8PM

Drawings every Sunday, every half-hour from 4PM to 8PM

Winner Breakdown: Total of nine (9) winners each week

Prize Minimum: \$250 Cash **Prize Maximum:** \$250,000 Cash

1. To be eligible for this promotion, player (hereafter “player” or “players”) must be a current ONE club member in good standing.
2. New members are qualified for this promotion upon valid enrollment.
3. This promotion is available at Quil Ceda Creek Casino.
4. Entries are earned for all recorded slots play or table games play.
5. Entries can be earned from November 25 at 6AM through December 29, 2024, at 8PM.
6. Entries are awarded through the following:
 - SLOTS: Players earn entries for every 10 points earned:
 - i. Red Card = (1) entry
 - ii. Gold Card = (2) entries
 - iii. Platinum Card = (3) entries
 - iv. Black Card = (4) entries
 - TABLE GAMES: Players earn entries for every one (1) comp dollar earned:
 - i. Red Card = (2) entries
 - ii. Gold Card = (4) entries
 - iii. Platinum Card = (6) entries
 - iv. Black Card = (8) entries
7. It is the responsibility of the player to use their ONE club card at the time of play. Entries will not be adjusted for unrecorded play.

Daily Kiosk Award

1. Upon accessing their account, guests will select the promotions tab, then the promotions tile.
2. Each guest will be awarded a set number of bonus entries for the weekly drawings based on their current tier and play for that day.
3. Black and Platinum tier level players are pre-qualified to play the bonus entry game. Red and Gold tier level players must earn twenty (20) points per day to qualify to play the bonus entry game.
4. Limited to one (1) attempt at Quil Ceda Creek Casino, per guest, per day, from 1AM – 11:59PM.
5. Entries must be redeemed at any QCC promotional kiosk and will not be awarded retroactively.

New Sign-Up Bonus Entries

1. Any eligible ONE club member who signs up for a new account from December 1, 2024, through December 24, 2024, will be able to participate.
2. Entries must be redeemed at any QCC promotional kiosk and will not be awarded retroactively.
3. Upon activation at the kiosk, the entries will automatically be added to the guest's account.

Rules:

1. Drawings will be held on Sundays; December 1, 8, 15, 22 and 29, 2024, every half-hour from 4PM to 8PM.
2. To activate virtual entries, a player must use their ONE club card at any promotional kiosk or slot machine during the one (1) hour prior to each drawing time.
3. All entries are virtual and are maintained, awarded and randomly selected through an electronic drawing system.
4. One (1) winner will be drawn at each drawing time, for a total of nine (9) winners each promotional day.
5. All winners must be present at time of drawing.
6. Selected winners will have three (3) minutes to claim after their name is announced on the overhead. If a winner does not claim within the three (3) minutes, an alternate winner will be drawn.
7. Each winner will select a present from the bottom level of the electronic gameboard. The present will either say "pick again" or "sorry." If it says pick again, the winner selects a present from the next level. If it says sorry, the winner does not continue but wins the amount from the level they are currently on.
