



Big Game Pick 'Em

Official Rules

Promotional Period: February 3, 2025 – February 9, 2025

Drawings on Sunday, February 9, 2025, after each game quarter

Winner Breakdown:

- Ten (10) winners after the first, second, and third quarter at Tulalip Resort Casino
- Three (3) winners after the fourth quarter at Tulalip Resort Casino
- Ten (10) winners after the first, second, and third quarter at Quil Ceda Creek Casino
- Three (3) winners after the fourth quarter at Quil Ceda Creek Casino

Prize Minimum: \$100 Free Play **Prize Maximum:** \$10,000 Free Play

1. To be eligible for this promotion, player (hereafter “player” or “players”) must be a current ONE club member in good standing.
2. Player must be a current ONE club member with a valid pin to be eligible to participate.
3. New members are qualified for this promotion upon valid enrollment.
4. This promotion is available at Tulalip Resort Casino or Quil Ceda Creek Casino.
5. This promotion will occur on Sunday, February 9, 2025, from 12PM – 8PM.
6. Players can visit any kiosk from February 3 – February 9 and select one (1) of the two (2) available teams to win the Big Game. Guests are limited to a single selection.
7. Once a player meets qualifications, player must visit a ONE club promotional kiosk and:
 - Swipe their ONE club card
 - Select promotion
 - Enter valid pin
 - Select promotional tile
 - Follow play prompt
8. A player is limited to one (1) participation. When participation is redeemed at one (1) property, it will not be available for the player at any other property.

Bonus Entries

1. Any ONE club member that is a DraftKings mobile user is eligible for bonus entries.
2. Upon verification, fifty (50) bonus entries will be added to their account.
3. Guests are limited to one (1) participation. Once redeemed at one property, it will not be available to the guest at the other property.

First, Second, and Third Quarter Drawings:

1. Drawings will occur on Sunday, February 9, 2025, at each property, Tulalip Resort Casino and Quil Ceda Creek Casino.
2. Winning names will be drawn and announced via the overhead system. Guests must be present at the time of drawing to win.
3. Ten (10) winners will be announced at the end of the first, second, and third quarter.
4. Each of the winning names will be awarded \$100 Free Play.
5. If the team selected by the winner is in the lead for that drawing time, the winner will receive double the Free Play prize.
6. Guests must use Free Play at a slot machine; cash-out option is not available for this promotion.
7. Promo Free Play credits valued at \$250 and under will expire twenty-four (24) hours after prize activation.
8. Any Free Play prize that is not activated within the allotted activation period, or expired, will not be reissued.

Grand Prize Drawing:

1. Drawing will occur on Sunday, February 9, 2025, at each property, Tulalip Resort Casino and Quil Ceda Creek Casino fifteen (15) minutes after the game.

3. Winning names will be drawn and announced via the overhead system. Guests must be present at the time of drawing to win.
4. Three (3) winners will be announced fifteen (15) minutes after the end of the game.
5. Guests will have three (3) minutes to report to the promotional area once their name is announced. If a winner does not respond within the allotted time frame, another virtual winner will be drawn and announced.
6. Guests may refuse to participate. If a guest refuses, another name will be drawn to replace them.
7. Winners will compete on a football field gameboard. Each player will spin the wheel to determine how many spaces to advance on the gameboard. The first player to move their game piece across the goal line will be deemed the winner.
