1. To be eligible for this promotion, player (hereafter “player” or “players”) must be a current ONE club member in good standing.
2. New members are qualified for this promotion upon valid enrollment.

4. This promotion will occur on Wednesday, February 5, 12, 19 and 26, 2025, every half-hour from 4PM – 8PM.
5. Players must be playing with their card inserted in a slot machine or actively rated at a table in table games to be eligible.
6. Black and Platinum tiers are automatically qualified.
7. Gold and Red tiers must earn twenty (20) promo slot points on each drawing day to qualify.
8. Players must activate the promotion, whether complimentary or earned, at a promotional kiosk between 3PM and 7:55PM.
9. Hotseat winners will be randomly selected by the player tracking system from qualified active players.
