



Super Jewel Multiplier Official Rules

Promotional Period: February 4, 2025, at 10AM – February 25, 2025, at 10PM

Redemption Dates: Every Tuesday in February from 10AM to 10PM

Prize Minimum: 2X Points **Prize Maximum:** 15X Points

1. To be eligible for this promotion, player (hereafter “player” or “players”) must be a current ONE club member in good standing or enroll to become one.
2. This promotion will occur on Tuesdays; February 4, 11, 18 and 25, 2025.
3. Guests will visit the kiosk each Tuesday between 10AM and 10PM to receive their multiplier.
4. Player must visit a ONE club promotional kiosk and:
 - Swipe their ONE club card.
 - Select promotion.
 - Enter valid pin.
 - Select promotional tile.
 - Once selected, the kiosk will activate the multiplier.
5. Total of one (1) redemption per player each Tuesday.
6. Guest’s account is restricted to one (1) active multiplier on their account during this promotion, including any multipliers awarded at their tier level. Guests will automatically qualify for the highest multiplier awarded to them.
7. It is the responsibility of the player to use their card. Any play prior to registering at the kiosk for Super Jewel Multiplier will not qualify for the multiplier.
8. Only base promo slot points are eligible for multipliers. Base promo does not award points for any slot play attained by Free Play or point cash-out.
9. Multiplier is active from the time of award for a maximum of four (4) hours, or until 10:30PM.
10. Awarded cashback points are recorded as a bonus and are not eligible towards other promotions or tier advancement.
11. Any player found to be abusing the promotion rules or tampering with the promotion in any way may be disqualified and declared ineligible.
12. Management reserves the right to modify or terminate this promotion at any time at its sole discretion with or without notice, subject to Tulalip Tribal Gaming Agency approval. All rulings made by event management during the promotion are final. Any prize awarded due to a system,

screen or printing error will become void and will not be paid out. All rulings made by management are final.

13. Qualification, participation and redemption requirements for this promotion are limited to Quil Ceda Creek Casino.
14. Tulalip Gaming Organization and its affiliates are not responsible for kiosk or mobile app being unavailable due to system malfunction and can deny any payout due to kiosk malfunction.
