- 1. To be eligible for this promotion, player (hereafter "player" or "players") must be a current ONE club member in good standing.
- 2. New members are qualified for this promotion upon valid enrollment.
- 3. This promotion is available at Tulalip Resort Casino or Quil Ceda Creek Casino.
- 4. Players must log into their account on a promotional kiosk at one (1) property of their choice between June 28, 2025, 8AM and July 3, 2025, at 11:59PM to activate this promotion.
- 5. Upon activating the promotion, the guest will be prompted to spin the wheel on the screen. A Free Play prize will be awarded upon selection.
- 6. Players must visit a ONE club promotion kiosk and:
 - Swipe their ONE club card
 - Select promotion
 - Enter valid pin
 - Select promotional tile
 - Follow play prompt
- Upon award, the player will be informed that the prize can only be redeemed on Friday, July 4, 2025, from 10AM – 10PM.
- 8. Players are limited to one (1) kiosk participation. Once redeemed at one (1) property, it will not be available at any other property.
- 9. Promo Free Play must be activated on July 4, from 10AM to 10PM. To activate, a player must use their ONE club card at any slot machine at Tulalip Resort Casino or Quil Ceda Creek Casino.
- 10. Players must use promo Free Play at a slot machine; cash-out option is not available for this promotion.
- 11. Promo Free Play valued at \$250 or less will expire twenty-four (24) hours from prize activation.
