- 1. To be eligible for this promotion, the player (hereafter "player" or "players") must be a current ONE club member in good standing.
- 2. New members are qualified for this promotion upon valid enrollment.
- 3. Promotion will be held at Tulalip Resort Casino on Fridays in January: January 2, 9, 16, 23 and 30 2026, from 4PM to 8PM.
- 4. Promotion will be held at Quil Ceda Creek Casino on Thursdays in January: January 8, 15, 22 and 29 2026, from 4PM to 8PM.

Bonus Kiosk Award

- 1. Guests can visit a kiosk from Thursday Tuesday once per day for bonus entries.
- 2. Upon accessing their account, guests will select the promotions tab, then the promotions tile to reveal bonus entries.
- 3. Limited to one (1) attempt at Tulalip Resort Casino or Quil Ceda Creek Casino, per guest, Thursday Tuesday, from 1AM –11:59PM. Excludes Wednesdays
- 4. Red and Gold tiers must earn twenty (20) promo slot points daily to qualify. Platinum and Black tiers are prequalified.

New Sign-Up Bonus Entries

- 1. Beginning January 1, 2026, through the final drawing day at 7:59PM, guests can visit a kiosk for new sign-up bonus entries.
- 2. Any eligible ONE club member who signs up for a new account from January 1 through January 31 will be able to participate.
- 3. Upon accessing their account, guests will select the promotions tab, and then the promotion tile.

Promotional Days

- 1. On promotion days, a ONE club member must activate their virtual entries by using their ONE club card at a promotional kiosk between 4PM 7:55PM.
- 2. Upon playing the game, the kiosk system will randomly award a prize to each player.
- 3. If a guest wins a physical prize, the kiosk will print a voucher that must be redeemed at the prize table on the day of award by 8:30PM.
- 4. Prizes include Free Play and various gift cards.
- 5. One (1) winner will be chosen at Quil Ceda Creek Casino from the kiosk management system at 8PM on January 8, 15, and 22, 2026. The winner will be awarded an instant \$5,000 cash prize.
- 6. One (1) winner will be chosen at Tulalip Resort Casino from the kiosk management system at 8PM on January 2, 9, and 16, 2026. The winner will be awarded an instant \$5,000 cash prize.
- 7. Guests must use Free Play at a slot machine; cash-out option is not available for this promotion.
- 8. Guests are responsible for activating Free Play by inserting their ONE club card into a slot machine within four (4) hours of award.
- 9. Free Play prizes will expire after twenty-four (24) hours.
- 10. Inactivated or expired Free Play will not be reissued unless approved by marketing management.

Grand Prize Drawing

- 2. To be eligible for this drawing, entries must be activated no more than one (1) hour prior and no less than five (5) minutes before the grand prize drawing.
- 3. Winning names will be drawn and announced via the overhead system; guests must be present at the time of drawing to win.
- 4. One (1) winner will be announced at 8PM.
- 5. Winners will have three (3) minutes to claim after their name is announced on the overhead. If a winner does not claim within three (3) minutes, an alternate winner will be announced.
- 6. The winner will be awarded a \$5,000 cash prize on that day. Then the \$5,000 prize will be paid monthly; a check will be mailed to the winner prior to the tenth day of each month for eleven (11) consecutive months, beginning at the time of award and continuing no later than December 31, 2026.
